

109 W. Brazzill Lateral beginning on the Southeast quarter of the Northeast quarter (SE₄NE₄) of Section 21, Tp. 33 N. of R. 109 W., running through the Northeast quarter of the Southeast quarter (NE₂SE₂) of Section 2, and the Northwest quarter of the Southwest quarter (NW₂SW₂) of Section 1, and the Southwest quarter of the Northwest quarter (SW₂NW₂) of Section 1, in Tp. 33 N. of R. 109 W. 101 Lateral beginning on the Southeast quarter of the Northeast quarter (SE₄NE₄) of Section 27, Tp. 34 N. of R. 109 W., in a southerly direction through Section 34, Tp. 34 N. of R. 109 W. of the 6th P.M. to the Township line.

That between the dates of May 28th, 1925, and the 5th day of November, 1931, inclusive, pursuant to a written contract between the duly authorized officers and agents of Fremont Lake Irrigation Company, the said J. W. Brazzill performed work and labor and furnished money and transportation for said Fremont Lake Irrigation Company, at their special instance and request, and for which said work and labor, money and transportation and other things mentioned in the itemized statement attached hereto the said Fremont Lake Irrigation Company promised and agreed to pay, which said detailed and itemized statement is hereunto attached, marked Exhibit A., and by this reference made a part hereof.

That the itemized statement hereto attached is a just and true account of all demands and claims due the said J. W. Brazzill after all just credits and off-sets have been given and allowed, and that there is now due and owing on said account, as aforesaid, the sum of \$6,349.82, together with interest thereon at the rate of 7% per annum from the 5th day of November, 1931, until paid.

That the said work and labor and money and transportation and other things mentioned in the itemized statement hereunto attached and furnished the said Fremont Lake Irrigation Company, as aforesaid, were furnished in the building, constructing and maintaining of an irrigation canal, head gates, main ditches and laterals as hereinbefore described in this notice.

That the said J. W. Brazzill claims a lien upon the premises and lands hereinbefore described, together with a lien upon all of the personal property belonging to said Fremont Lake Irrigation Company, and situated upon any of the above described premises.

That a period of more than sixty days has elapsed from the furnishing of said last item, as mentioned in said itemized statement.

That demand has been made upon the said Fremont Lake Irrigation Company for the payment of the amount due.

That less than Ninety days has expired since the aforesaid account has become and was due and that said account is now due, and that this notice is filed for the purpose of obtaining a lien against the property herein described and against the Fremont Lake Irrigation Company, and against all other persons claiming through or under them, in conformity with Chapter 308, Wyoming Compiled Statutes, 1920.
