One black horse, 16 hands high, weight about 850 lbs., branded ∞ on left front shoulder, age, 6 years.
One sorrel horse, 14½ hands high, weight about 800 lbs., age 7 years. Branded ∪ on left front shoulder (single footer).
One grey horse, 14½ hands high, weight about 800 lbs., age 8 years, blind in left eye.
One sorrel horse, 16 hands high, weight about 950 lbs., age 5 years, wire cut on right hind leg.
One bay horse, 15 hands high, weight 850 lbs., age 7 years, star in forehead. White spot on nose, two white hind feet, one white front foot.
One sorrel mare, 15 hands high; weight 850 lbs., age 6 years, two white hind legs to hock joints.
Three old stock saddles; one good Nigger Boy saddle, two pack saddles, two sets of canvas panyards, 6 bridles; 3 hackamores; 3 halters; 6 blankets; one home made bob sled.
