THIS AGREEMENT, made this 29th day of August, 1933, by and between Marion Aitken hereinafter called the party of the first part, and L. H. Hennick, hereinafter called the party of the second part,

WITNESSETH, That said party of the first part, for and in consideration of the covenants and agreements hereinafter mentioned to be kept and performed by the said party of the second part, his heirs, executors, administrators and assigns, has demised and leased to the said party of the second part all those premises situate, lying and being in the County of Sublette and the State of Wyoming, described as follows, to-wit:
