KNOW ALL MEN BY THESE PRESENTS: That The Cora Mercantile Company a corporation, of Sublette County, State of Wyoming, does hereby grant to SUBLETTE COUNTY, WYOMING, a certain tract of land more particularly described as follows:

A strip of land 80 feet in width, over, upon and across the following described land: S $\frac{1}{2}$ SW $\frac{1}{4}$, Section 3; T. 34 N., R. 110 W., 6th P. M., Sublette County, Wyoming, the center line of which is described as follows: Beginning on a point near the southwest corner of Section 3; T. 34 N., R. 110 W., and running thence east along the section line, a distance of one mile to the southeast corner of said Section 3; T. 34 N., R. 110 W.,

The above described tract being more specifically shown upon a map of record in the office of the County Clerk of Sublette County, Wyoming.

TO HAVE AND TO USE continuously and perpetually the said described tract of land for the use and benefit of a public highway, and for the purpose of constructing and maintaining a public highway, thereon.
