

situated in the County of Sublette, State of Wyoming, the undersigned, who is the holder of the first mortgage upon said property, hereby agrees not to proceed against the mortgagor and/or the mortgaged property for any default in the payment of the principal of said first mortgage indebtedness or any part thereof, for a period of three years from the date of this instrument, unless the Land Bank Commissioner shall have consented in writing to such proceedings. In the event that the Commissioner shall consent in writing to such proceeding during said period, or if any proceeding shall be brought against the mortgagor and/or the mortgaged property after the expiration of said period, but while the second mortgage is still in force, the undersigned further agrees in either case to give notice thereof in writing to the Land Bank Commissioner at his office in the City of Omaha, Nebraska, at least thirty days prior to the actual institution of such proceeding. This agreement shall be binding upon said first mortgagee's assigns and/or successors in interest.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, in pursuance of the laws of the State of Wyoming, in such cases made and provided, the Most Reverend Patrick A. McGovern, Bishop of Cheyenne, (being the chief officer of the Roman Catholic Church in the Diocese of Cheyenne, and having spiritual jurisdiction extending over the whole thereof, the same comprising the entire State of Wyoming,) on the 30th day of March, 1934, convened a meeting at Big Piney, Wyoming, consisting of himself, the said Most Reverend Patrick A. McGovern, Very Rev. John T. Nicholson, Vicar General, (being a subordinate officer of said Roman Catholic Church in the said Diocese of Cheyenne, and having spiritual jurisdiction throughout the same,), Reverend John McDevitt being pastor of the Church known as St. Anne of Big Piney, located at Big Piney, in said State, and Arnold Olson and Solon Murdock two laymembers of said last named church and residing within the limits of said parish; and WHEREAS, said meeting was called for the purpose of incorporating said last named church in accordance with the provisions of the laws of said State, and the said Most Reverend Patrick A. McGovern presided at said meeting, and the said Solon Murdock was duly elected secretary thereof: NOW, THEREFORE, the said Most Reverend Patrick A. McGovern, Bishop aforesaid, Very Rev. John T. Nicholson, Vicar General aforesaid, Rev. John McDevitt pastor aforesaid, Arnold Olson and Solon Murdock, laymen, aforesaid, at said meeting so convened and organized, do further in pursuance of said law and for the purpose aforesaid, adopt, in duplicate, the following Articles of Incorporation:

1. The name of this corporation shall be Church of St. Anne of Big Piney, and the place of its location shall be Big Piney in the County of Sublette, in the State of Wyoming.

2. The object and purpose of this corporation is to receive, hold and manage all such properties, rights, titles, privileges, powers and affairs of the Roman Catholic Church in said parish that may be legally so received, held and managed by it consistently and in such a manner as in no wise to conflict with the independent jurisdiction of its established spiritual authorities or with its established order of spiritual government; and in so doing to acquire and hold the legal title to such property, real and personal, as may be required for the use of said Church in each and all of its departments, and to convey the same and contract with re-
