THIS AGREEMENT, made and entered into this 10th day of February, 1933, by and between ABNER LUMAN COMPANY, a corporation, organized and existing under and by virtue of the laws of the state of Wyoming, with its principal place of business situate at Pinedale, Wyoming, hereinafter called the party of the first part, and RAYMOND E. WOOLERY, of Pinedale, Wyoming, hereinafter called the party of the second part,

WITNESSETH; that said party of the first part, for and in consideration of the sum of Three Thousand Seven Hundred Fifty & 00/100 Dollars (\$3,750.00) to be paid by said party of the second part as hereinafter provided, and upon the express condition, which is hereby declared a condition precedent, time being of the essence of such conditions, that the said party of the second part, his heirs, executors, administrators or assigns, shall, and do well and faithfully perform the covenants and agreements hereinafter mentioned on his part to be kept and performed, does hereby for itself, its successors and assigns, covenant and agree to CONVEY AND ASSURE to said party of the second part, by a good and sufficient Warranty Deed, and a good and sufficient bill of sale, subject, however, to the taxes for the year A. D. 1933, and subsequent taxes of every kind and nature, the following described real and personal property, situate, lying and being in the county of Sublette, state of Wyoming, and more particularly described as follows:
