ORDER

Effie May Rahm, the widowed spouse and an heir at law, and legatee and devisee of the estate of John J. Rahm, deceased, having filed herein her petition praying among other things that an order be made to re-open said estate, and that a supplemental order be made correct- ing and modifying the description of the real estate described in that certain Amended Decree and Order of Distribution made by the Honorable E. H. Fourt, Judge of this Court, on the 7th day of July, 1927, and which was filed on said day and duly recorded in Estate Book H, page 218, and the Court having this day examined the records herein, and having heard the evidence adduced in behalf of the petitioner, and being fully advised in the premises, doth find:

That upon the filing of said petition, the Clerk of this Court did appoint a day for the hearing of said petition, and did give notice thereof by causing notice to be published at least once a week for three successive weeks, in the Wind River Mountaineer, a weekly newspaper published at Lander, Fremont County, Wyoming, and of general circulation through- out the State of Wyoming; the editor's Affidavit of Publication being on file herein, and

The Court doth further find that the Clerk of this Court did mail by registered letter a copy of said notice to the heirs and all of the heirs at law, devisees, legatees and dist- ributees named in said petition, at their last known address, and

The Court doth further find that by error the

was erroneously included therein, and should be excluded herefrom.

The Court doth further find that in every other respect the order heretofore referred to was proper and correct.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the real estate set out in said Amended Decree of Account and Final Distribution should and the same is hereby made to read as follows:

The West half of the Southwest quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$) of Section 27; the East half of the Southeast quarter (E $\frac{1}{2}$ SE $\frac{1}{4}$) and the Northwest quarter of the Southeast quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 28; the East half of the East half (E $\frac{1}{2}$ E $\frac{1}{2}$) of Section 33; the South half (S $\frac{1}{2}$) of Section 34; the South half of the Northwest quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$), the Southwest quarter (SW $\frac{1}{4}$), the West half of the Southeast quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$), and the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 35; the South half (S $\frac{1}{2}$) of Section 36, all in Township 35 North, Range 110 West of the 6th Principal Meridian; and
