

Now on this 9th day of September, 1935, came Albert B. Duke, assignee of the heirs at law of Carl Sorenson, deceased, and thereupon the establishment, ascertainment and determination of the heirs at law of Carl Sorenson, deceased, coming on regularly to be heard, upon the petition of Albert B. Duke, pursuant to an Order made and entered by this Court on the 11th day of July, 1935, and it further appearing that Notice of time and place of hearing has been regularly published according to law, as evidenced by the affidavit of the publisher of the Pinedale Roundup, a weekly newspaper of general circulation, regularly published in the Town of Pinedale, County of Sublette, State of Wyoming, which said affidavit is on file herein.

Thereupon the Court having considered said petition, and the evidence and proofs adduced herein, and being fully advised in the premises doth find, establish, ascertain and determine that said deceased, Carl Sorenson, died on or about the 21st day of July, 1916, in the territory now embraced in the County of Sublette, State of Wyoming, while a resident thereof; and that prior to his death, the decedent had made entries on government lands within said territory, and had not yet received patents therefor.

That on the 17th day of May, 1920, the United States of America issued to the heirs of Carl Sorenson, deceased, a patent giving and granting to the said heirs of Carl Sorenson, the following described lands, to-wit:

The North half of the Southwest quarter ($N_1SW_4^1$) of Section 1, and the North half of the Southeast quarter ($N_2SE_4^1$) of Section 2, in Township 35 North, Range 113 West of the 6th Principal Meridian, Wyoming, containing 160 acres.

That thereafter, to-wit: On the 15th day of October, 1920, the United States of America issued to the heirs of said Carl Sorenson, deceased, a patent, giving and granting to the heirs of said Carl Sorenson the following described lands, to-wit:

The East half of the Southwest quarter ($E_2SW_4^1$) and the South half of the Southeast quarter ($S_2SE_4^1$) of Section 2, in Township 35 North, Range 113 West of the 6th Principal Meridian, Wyoming, containing 160 acres.

That thereafter Violet Stover, niece of said deceased, Lelian S. Tinkcom and Daisy S. Beck, sisters of said deceased, they then and there being over the age of twenty-one years, and the heirs and only heirs at law of said deceased, conveyed to your petitioner Albert B. Duke, all of the lands embraced in said patents, as is evidenced by the records of the County Clerk and Ex-Officio Register of Deeds of Sublette County, Wyoming.

That due and sufficient notice hereof has been published, given and had according to law.

That the sole and only heirs at law of said Carl Sorenson, deceased, are: Violet Stover, Lelian S. Tinkcom and Daisy S. Beck; and that all of the above named heirs survive the said deceased.

IT IS THEREFORE ORDERED, ADJUDGED, DECREED AND ESTABLISHED that the said Carl Sorenson died on or about the 21st day of July, 1916, and left him surviving as his sole and only heirs at law, and their interest in said estate, as follows:

AND IT IS FURTHER ORDERED, ADJUDGED, DECREED AND ESTABLISHED that Albert B. Duke, as assignee of said heirs at law, and as evidenced by the records of the County Clerk and Ex-Officio Register of Deeds of Sublette County, Wyoming, is the only person who is entitled to any right, title or interest in and to the said above described lands, under and by virtue of said patents.

IT IS FURTHER ORDERED that the cost of this proceeding shall be paid by the petitioner herein.

IT IS FURTHER ORDERED AND DECREED that the lands set over to Albert B. Duke, under and by virtue of this decree, are particularly described as follows, to-wit:

The North half of the Southwest quarter ($N_1SW_4^1$) of Section 1, and the North Half of the Southeast quarter ($N_2SE_4^1$) of Section 2, in Township 35 North, Range 113 West of the 6th Principal Meridian, Wyoming, containing 160 acres, and

The East half of the Southwest quarter ($E_2SW_4^1$) and the South half of the Southeast quarter ($S_2SE_4^1$) of Section 2, in Township 35 North, Range 113 West of the 6th Principal Meridian, Wyoming, containing 160 acres.

IT IS FURTHER ORDERED that the Clerk of this Court cause a certified copy of this order to be recorded in the office of the County Clerk and Ex-Officio Register of Deeds of Sublette County, Wyoming.
