ORDER CONFIRMING SALE OF REAL ESTATE

Now comes Charles Hiles, the administrator of said estate, by his attorney, G. B. Hockett, and proving to the satisfaction of this Court that his return of sale of real estate under the order of sale hereinbefore made, was duly filed in the office of the Clerk of this Court on Monday, April 15, 1932; that thereafter the Court fixed Wednesday, May 4, 1932, as the day for hearing thereof; that on said day and after examining the said return, and hearing the evidence the Court advises therefrom that said sale was legally made and fairly conducted; that the same was a private sale in the manner and form as prescribed by law and the order of this Court; that the price obtained thereat was the reasonable value of the property sold and that no greater sum can be obtained; That there are no objections thereto or higher offers therefor.

IT IS THEREFORE ORDERED by the Court that the sale of the real estate as in said return of sale and hereinafter described, to Helen W. Hiles, for the sum of Three Thousand Four Hundred Thirty-three and 44/100 Dollars (\$3,433.44) in cash, that is to say: the sum of \$343.34 paid to this administrator by the said Helen W. Hiles at the time of said sale, the said sum being 10% of the whole amount offered therefor and the balance to be paid to this administrator upon confirmation by this Court of said sale, be and the same is hereby confirmed; and upon payment of the amount aforesaid, the said Charles Hiles as administrator of the estate of said deceased is hereby directed to execute to the said purchaser, Helen W. Hiles, a proper deed of conveyance thereof.
