Whereas, the proof of construction sets forth that said reservoir has been completed in accordance with the terms of said permit to a capacity sufficient to impound 5377.92 acre-feet of water; and that the source of the quantity of water authorized to be stored in the FREMONT LAKE Reservoir to meet the legal water requirements of dependent secondary permits, is obtained from PINE CREEK, TRIB. WEST FORK OF NEW FORK RIVER, TRIB. NEW FORK RIVER on which the reservoir is located, and-----through the-----Ditch, Permit No.-----.
