

option to purchase, as above provided, the lessee shall have the right to remove all buildings and improvements from the real property herein described.

IT IS FURTHER AGREED By the parties hereto that the lessee shall have the right to underlet said premises or any part thereof, or assign this Lease without the written consent of the said party of the first part, had and obtained thereto; provided, however, that said lessee shall remain liable for all rentals which may be due or become due under this Lease.

IT IS EXPRESSLY UNDERSTOOD AND AGREED By and between the parties aforesaid, that if the rent above mentioned, or any part thereof, shall be unpaid on the date of payment whereon the same ought to be paid as aforesaid, or if default shall be made in any of the covenants or agreements herein contained, to be kept by said party of the second part, his executors, heirs, administrators or assigns, it shall and may be lawful for the said party of the first part, her heirs, executors, administrators, agent, attorneys or assigns, at their election to declare said term ended, and into the said premises, or any part thereof, either with or without process of law, to re-enter. And if at any time said term shall be ended at such election of said party of the first part, her heirs, executors, administrators or assigns as aforesaid, or in any other way, the said party of the second part, his heirs, executors, administrators and assigns, do hereby covenant and agree to surrender and deliver up the said above described premises and property peaceably to said party of the first part, her heirs, executors, administrators and assigns, immediately upon the termination of said term as aforesaid, and if he shall remain in possession of the same ten (10) days after notice of such default, or after the termination of this Lease in any of the ways above named, he shall be deemed guilty of forcible detainer of said premises under the statute, and shall be subject to conditions and provisions above named, and to eviction and removal, forcible or otherwise, with or without process of law as above stated.
