KNOW ALL MEN BY THESE PRESENTS, That William Iredale, Hilda Wiederanders, John Mudd, Robert Mudd, Phronie Mudd Bruce of the County of Sweetwater, in the State of Wyoming for and in consideration of the sum of Six Hundred (\$600.00) DOLLARS (\$600.00), to them in hand well and truly paid at or before the signing, sealing and delivery of these presents by Albert Crippa, of the County of Sweetwater, in the State of Wyoming, the receipt whereof, they, the said William Iredale et al, do hereby acknowledge, have granted, bargained, sold and delivered, and by these presents do grant, bargain, sell, and deliver unto the said Albert Crippa the following goods and chattels, to-wit:
