And the said party of the first part does hereby make, constitute and appoint the party of the second part, or his substitute, the true and lawful attorney of said first party, with full power and authority to enforce the said royalties, rights and interest, as fully, to all intents and purposes, as first party might or could do if this instrument had not been executed.

TO HAVE AND TO HOLD, the said royalties, rights and interest unto the said party of the second part, his heirs and assigns, for and during the entire life, term and duration of the said oil and gas prospecting permit and any and all lease or leases issued on said lands pursuant to the terms thereof.
