FINDINGS AND ORDER

THIS MATTER coming regularly before the State Board of Control this 9th day of November, 1938, the Board FINDS:

THAT the petitioner sets forth, under oath, that he is the sole owner of the Northwest Quarter of the Northeast Quarter (NW₄NE₄) of Section 34, Township 37 North, Range 113 West and of the appropriation of water granted under Permit No. 1373 Enl. with priority of February 15, 1905 diverting water from Hoback River, tributary of Snake River through the Enlargement Noble Ditch for the irrigation of 30 acres of land adjudicated as follows:

30 acres NW₄NE₄, Section 34, Township 37 North, Range 113 West

as evidenced by Certificate Record 49, Page 420 and recorded in Order Record 9, Page 95, Proof No. 21115;

THAT under date of November 23, 1935 a certificate of appropriation of water was issued to Charles P. Noble, as evidenced by Certificate Record 49, Page 420, for the irrigation of certain lands in Permit No. 1373 Enl. through the Enlargement Noble Ditch among which was included 30 acres in the Northwest Quarter of the Northeast Quarter (NW₄NE₄) of Section 34, Township 37 North, Range 113 West;

THAT at the time the above mentioned certificate was issued said Charles P. Noble did not own said subdivision and the petitioner was the owner by patent from the United States Government of said land;

THAT the petitioner now desires the cancellation of that part of said certificate of appropriation covering 30 acres in the Northwest Quarter of the Northeast Quarter (NW₄NE₄) of Section 34, Township 37 North, Range 113 West for the reason that the said subdivision has
