The Board, having considered the petition and being advised by the records of the office of the State Board of Control and the showings presented in the matter, THEREFORE ORDERS:

THAT the petition be GRANTED;

THAT the right to divert water from Hoback River, tributary of Snake River under Permit No. 1373 Enl. through the Enlargement Noble Ditch for the irrigation of 30 acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 34, Township 37 North, Range 113 West as evidenced by Certificate Record 49, Page 420; Order Record 9, Page 95; Proof No. 21115, be and the same hereby is CANCELLED.
