

WHEREAS, the foregoing application of November 23, 1937, was accepted by the United States Land Office and Serial No. 020165 was duly assigned to the above mentioned oil and gas lease application by the Register of the Evanston Land Office.

WHEREAS, on December 1, 1938, Kay Easton assigned to W. D. McKinley of Rock Springs, Wyoming, all of her right, title and interest in oil and gas application, Serial No. Evanston 020165, reserving unto herself a net overriding royalty interest of one and one half per cent (1½%), said royalty interest of one and one half per cent (1½%) being conditioned on the issuance of an oil and gas lease by the United States pursuant to the above mentioned oil and gas lease application and the assignment thereof.

WHEREAS, on January 31st, 1939, the aforesaid Kay Easton assigned to Harve Hazen, of Rock Springs, Wyoming, a royalty interest in the oil and gas produced, saved and marketed from the lands described in said oil and gas lease application that shall be secured in any lease from the United States pursuant to said application, equal to 3/8 of 1% of net overriding royalty of the oil and gas produced, saved and marketed from said lands, subject to all of the terms and conditions of the assignment of said oil and gas lease application from Kay Easton to W. D. McKinley hereinabove referred to and which said assignment is by reference expressly made a part thereof.

WHEREAS, on the twenty-third day of November, 1937, Mrs. Frances Hazen made application in the United States Land Office at Evanston, Wyoming, for an oil and gas lease pursuant to the Act of Congress of February 25, 1920, as amended by the Act of Congress of August 21, 1935. The foregoing oil and gas lease application covered the following described lands in Lincoln County, Wyoming:

WHEREAS, on the twenty-third day of November, 1937, Frank Prybylski made application in the United States Land Office at Evanston, Wyoming, for an oil and gas lease pursuant to the Act of Congress of February 25, 1920, as amended by the Act of Congress of August 21, 1935. The foregoing oil and gas lease application covered the following described lands in Sublette County, Wyoming:

Section 23, 27 North, Range 113 West of the 6th P.M. in Sublette County, Wyoming, Containing 640 acres more or less

D. McKinley hereinabove referred to and which said assignment is by reference expressly made a part thereof.

NOW THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00), and other valuable considerations in hand paid to the said Harve Hazen by the said Glenn D. Wilson, the receipt of which is hereby acknowledged, the said Harve Hazen does hereby sell, assign, transfer and convey unto the said Glenn D. Wilson of Rock Springs, Wyoming, his heirs, personal representatives and assigns, a royalty interest in the oil and gas produced, saved and marketed from the lands described in said oil and gas lease application that shall be secured in any lease from the United States pursuant to said application, equal to 12½% of 3/8 of 1% of net overriding royalty of the oil and gas produced, saved and marketed from said lands, subject to all of the terms and conditions of the assignments of said oil and gas lease applications from Kay Easton and Frank Prybylski to W. D. McKinley and Mrs. Frances Hazen to Cleigh Powers hereinabove referred to and which said assignments are by reference expressly made a part thereof.
