TO HAVE AND TO HOLD unto the said assignees, their heirs, administrators, and assigns, said royalty as above set forth, the said oil and gas so produced and saved from said lands to be delivered free of cost to the royalty owner in the pipe lines serving said premises or tanks erected thereupon for the purpose of storing such products, together with the rights, priviledges, and benefits to be derived therefrom; and do hereby assign said royalty under the lease now covering said lands, as well as any lease, or leases, that may be hereafter made covering said premises, and agree to warrant and defend the title to the same and we have lawful authority to sell and assign said three (3) acres of royalty.

The assignor reserves the right (and it is agreed to by the assignees to sell and dispose of the royalty oil or gas above conveyed to the purchaser or purchasers of his own oil and gas, subject to proper accounting for the proceeds thereof to the assignees herein named.

KNOW ALL MEN BY THESE PRESENT: That Mr. Clyde Lovelace and his wife Ethel Y. Lovelace of San Diego, California, for and in the consideration of Ten (\$10.00) dollars and other good and valuable consideration, in hand paid by Mr. W. B. Croka and his wife Sybil Croka of San Diego, California, hereafter called assignees, the receipt of which is hereby acknowledged and confessed, do hereby sell, assign, transfer, convey, and set over unto, the said assignees, all of our right title, and interest in and to three acres (3) of the 1/8 or 12 1/2% royalty of all the oil and gas produced and saved from the hereinafter described lands, located in the county of Sublet, State of Wyoming, to wit:
