KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of One and no/100 dollars, the receipt of which is hereby acknowledged and confessed, Musetta Hennick of the County of Sublette and the State of Wyoming hereinafter called the grantor, hereby grants to the State of Wyoming, hereinafter called the grantee, the right of lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sublette and State of Wyoming, to-wit:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Sec. 33, T. 34N., R. 109W., of the 6th P. M., Wyoming, and
NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Sec. 4, T. 33N., R. 109W., of the 6th P. M., Wyoming

The location, and width of right of way hereby granted is as follows:

A parcel of land lying between lines 108 feet apart, and outside the West corporate limits of the Town of Pinedale, Sublette County, Wyoming, being 50 feet on the right or Southerly side and 58 feet on the left or Northerly side, when measured at right angles and parallel to the following described center line of highway:

Beginning at a point which is the intersection of the West boundary of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 4, T. 33N., R. 109W., of the 6th P. M., Wyoming, and the North boundary of said Section 4, from which the NW corner of said Section 4, bears S. 89°57'W. 1329.8 feet; thence N. 89°57'E., along the North boundary of said Section 4, 1343.0 feet, to the point of intersection with West corporate limits of the town of Pinedale.

Said parcel of land containing 3.330 acres, more or less, of which 3.083 acres, more or less, are contained in the right of way of the present established road.

Grantee agrees to fill the barrow pit on the north side of the road in all of that part of the road within the corporate limits of the Town of Pinedale. The filling material used to fill said Barrow pit shall be furnished by the grantor from the old Pine Creek Channel on the north of said highway.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to fence the right of way on both sides with 4 wire fence with posts 20 feet apart, with gates at such points as are necessary. Grantor to maintain fence thereafter.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irrigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

The grant herein contained is an easement and shall be perpetual so long as said land is used for the aforementioned purposes.
