DECREE SETTING APART HOMESTEAD

This matter this day came on regularly to be heard upon the petition of Mrs. S. D. McKenner, administratrix of the estate of Sydney McKenner, deceased, praying for an order setting over to Mrs. S. D. McKenner, surviving widow of said deceased, as her absolute property, all of the property of said decedent, and proof having been made to the satisfaction of the Court that due notice of this hearing has regularly been given as required by law, and no cause being shown or objections made why all of the property of the estate of said decedent should not be set over to said widow and the Court having heard all of the evidence adduced doth find:

That all of the property of said estate, more particularly hereinafter described, is of a value of less than \$2500.00 and is exempt from execution under the exemption laws of this state, including the homestead, and that the same should be set over to said surviving widow as her absolute property, and all singular law, the evidence and the premises being heard, seen and understood by the Court,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that all that certain real property, situate in the County of Sublette, State of Wyoming, and described as follows, to-wit:

One (1), two (2), three (3), four (4), five (5), six (6) and seven (7), in Block eight (8), of the Jones addition to the Town of Pinedale, Wyoming, together with all improvements.

be and the same is hereby set over to Mrs. S. D. McKenner, the surviving widow of said deceased, as her absolute property, and to her heirs and assigns forever, and that no further proceedings shall be required in the administration of said estate unless further estate is discovered.

AND IT IS FURTHER ORDERED that a certified copy of this decree be recorded in the office of the County Clerk and Ex-Officio Register of Deeds within and for said Sublette County.
