14. This Agreement shall be assignable by the parties hereto as to their respective interests hereunder, in whole or in part, and shall be binding upon the heirs, executors, administrators, successors, and/or assigns of the respective parties; but this paragraph is subject to the North LaBarge Unit Agreement. This Agreement, unless sooner terminated by surrender, shall be and remain in force and effect during the life of said permit, and during the term of the lease or leases and all renewals thereof.
