JUDGMENT AND DEGREE

This cause coming on regularly to be heard on this twelfth (12th) day of December, A.D. 1939, on the petition of the plaintiffs and other pleadings herein filed; and, it appearing to the Court that service of summons together with petition was had on each and every one of the defendants named herein; and each and every defendant having filed his verified answer to plaintiffs' petition herein, wherein each and all of said defendants by their answer disclaimed any and all right, title, or interest to the lands and premises described in plaintiffs' said petition; and the Court having considered the evidence offered in support of plaintiffs' petition, and being fully advised in the premises doth find:

ON PLAINTIFFS' FIRST CAUSE OF ACTION:

That on the 27th day of September A. D., 1912 JOSEPHINE A. BUDD, widow of DANIEL B. BUDD, deceased, personally and as administratrix of the Estate of DANIEL B. BUDD, deceased, SADIE OSTERHOUT, CHARLES P. BUDD, JOHN C. BUDD, DAN B. BUDD, HENRY L. BUDD, JESS B. BUDD, the sole and only surviving heirs at law of said DANIEL B. BUDD, deceased, made, executed, and delivered to the STATE BANK OF BIG PINEY of Big Piney, Wyoming, as trustee of C. P. MacGLASHAN their certain CONTRACT BOND and filed the same for record on the 24th day of July, 1913, which was recorded in Book One (1) of AGREEMENTS, BONDS, AND CONTRACTS, Page Nine (9) in the office of the County Clerk and Ex-Officio Register of Deeds in and for the County of Lincoln, State of Wyoming, and was thereafter recorded in Book One (1) of TRANSCRIBED MIXED RECORDS, Page Six Hundred Twenty-nine (629) in the office of the County Clerk and Ex-Officio Register of Deeds of Sublette County, Wyoming; wherein it was agreed, among other things, that the said named JOSEPHINE A. BUDD, SADIE OSTERHOUT, CHARLES P., JOHN C., DAN B., HENRY L., AND JESS B. BUDD, the surviving heirs at law of DANIEL B. BUDD, deceased, as aforesaid, and JOSEPHINE A. BUDD as administratrix of said estate for a good and valuable consideration to make, execute, and deliver to the said C. P. MacGLASHAN, his heirs, and assigns a good and sufficient warranty Deed for the lands hereinafter described as follows, to-wit:

The Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Thirty-one (31), Township Thirty (30) North of Range One Hundred Eleven (111) West of the Sixth (6th) Principal Meridian, Wyoming, and the ten acres lying on the west line of the above mentioned land, in equal width in adjoining forty (40) acre subdivision, in all fifty (50) acres;

conveying to said C. P. MacGLASHAN, his heirs, assigns, and administrators a good and marketable title in fee simple to the said above described lands free and clear of all encumbrances.

The Court doth further find that thereafter the said C. P. MacGLASHAN, relying upon the performance of said CONTRACT BOND and the issuance to him of the deed for the said lands, did on the 15th day of September, 1913, cause the lands above described and hereinafter more particularly described to be surveyed, platted, and laid out to be known as the C. P. MacGLASHAN'S FIRST ADDITION TO THE TOWN OF BIG PINEY; and the streets and alleys as shown on said plat dedicated to the use of the public and duly caused the same to be filed in the
