all in the C. P. MacGLASHAN'S FIRST ADDITION TO THE TOWN OF BIG PINEY, Sublette County Wyoming, together with all buildings, improvements, water and water rights, ditches, dikes, dams and everthing thereunto appertaining or belonging.

as against the claims and demands in law or in equity by the said above named defendants and all persons appearing herein, their heirs, devisees, assignees, and grantees, known and unknown, of each and of all of them claiming or who might claim any right, title, interest, estate or lien upon said above mentioned and described premises and those to claim or claiming by, through, or under them, and that said defendants have no estate, right, title, or interest whatsoever in said lands and premises or any part thereof,

AND IT IS FURTHER ORDERED and decreed that said defendants and those claiming under them or any of them are hereby forever enjoined and forbidden from commencing or bringing any suit at law or in equity to distrub the said plaintiffs in their possession and title to said lands and premises and from setting up any claim or estate or interest therein adverse to the title of said plaintiffs herein; and from disturbing the plaintiffs in the quiet and peacable enjoyment of said heretofore lands as described in plaintiffs' first cause of action and by reason and by virtue of any claim or demand whatsoever.

AND IT IS FURTHER considered, ordered, adjudged, and decreed by the Court, and this does order, adjudge, and decree that the title and possession of the said plaintiff, State Bank of Big Piney, a Corporation, in and to the premises heretofore and as mentioned in the second cause of action by the State Bank of Big Piney, A corporation, be, and the same is hereby forever settled and quieted in the said plaintiff as against the claims and demands in law or at equity by the said above named defendants and against Mildred O. Mickelson now Mildred O. Mickelson Jensen and every other person whose appearance has been made in this action and against their heirs, devisees, legatees, assignees, and grantees, known and unknown, and against each and all of them claiming or who might claim any right, title, interest, or estate or lien upon said lands and premises particularly described as:

Lot Eleven (11) in Block Fourteen (14) of the C. P. MACGLASHAN'S FIRST ADDITION TO THE TOWN OF BIG PINEY, Sublette County Wyoming, together with all buildings, improvements and everything thereunto appertaining or belonging.

and those to claim or claiming by, through, or under them and that said defendants and the said Mildred O. Mickelson or her heirs, devisees, assignees, and grantees have no estate, right, title, or interest whatsoever in said lands and premises or any part thereof.

AND IT IS FURTHER ORDERED and decreed that said defendants and all persons, whose appearance are entered in this suit and Mildred O. Mickelson, now Mildred O. Mickelson Jensen, and all persons claiming under them or any of them are hereby forever enjoined and forbidden from commencing or bringing any suit at law or equity to stop the said plaintiffs in its possession and title to said lands and premises, and from setting up any claim or estate or interest therein adverse to the said plaintiff herein and from disturbing the plaintiff in the quiet and peaceable enjoyment of the said heretobefore and the plaintiff's second cause described lands and premises by reason or by virtue of any claim or demand whatsoever.
