DECREE SETTING APART HOMESTEAD

This matter coming on to be heard this day upon the Petition of Nan C. Anderson, Administratrix of the estate of Wm. A. Anderson, deceased, praying for an order setting over to Nan C. Anderson, wife of said deceased, as her absolute property, all of the property of said decedent, and proof having been made to the satisfaction of the Court that due notice of this hearing has regularly been given as required by law, and no cause being shown or objections made why all of the property of the estate of said deceased should not be set over to the said Nan C. Anderson, and the Court having examined the records and files in said cause and being now advised in the premises FINDS:

That all of the property of said estate more particularly hereinafter described, is of a value of less than \$2500.00, and is exempt from execution under the exemption laws of this State, including the Homestead, and that the same should be set over to said Nan C. Anderson as her absolute property, and all singular the law, the evidence and the premises being heard, seen and understood by the Court:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that all of the following described property, both real and personal, situate and being in the County of Sublette, State of Wyoming, be, and the same is hereby set over to Nan C. Anderson, the surviving wife of said deceased, as her absolute property, and to her heirs and assigns forever, and that no further proceedings shall be required in the Administration of said estate unless further estate be discovered:
