KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of One dollar, the receipt of which is hereby acknowledged and confessed, Laura E. West and G. L. West, her husband, of the County of Sublette and the State of Wyoming hereinafter called the grantor, hereby grants to Sublette County, Wyoming, hereinafter called the grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sublette and State of Wyoming, to-wit:

NE $\frac{1}{4}$ SE $\frac{1}{4}$  Sec. 8, Tp. 34 N., R. 111 W., 6th P. M.

The location, width of right of way hereby granted is as follows:

A right of way 80 feet in width, being 40 feet on each side of a center line described as follows:

Beginning on a point 490 feet East of the Northwest corner of NE $\frac{1}{4}$ SE $\frac{1}{4}$  Sec. 8, Tp. 34 N., R. 111 W., and running thence S. 58° 20' W., 420 feet; thence S. 44° 25' W., 190 feet to a point on the West line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$  Sec. 8, with a 3° curve at angle of intersection, containing 1.12 acres, more or less.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to fence the right of way on one side with 4 wire fence with posts 20 feet apart, with gates at such points as are necessary. Grantor to maintain fence thereafter.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irrigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

The grant herein contained is an easement and shall be perpetual so long as said land is used for the aforementioned purposes.
