DECREE OF SETTLEMENT OF ACCOUNT AND FINAL DISTRIBUTION.

Geo. A. Moffat, Administrator of the Estate of Frances Moffat, deceased, having filed herein, his account and report of his administration of said Estate, which account was for final settlement, and having with said account filed his petition for final distribution of said estate;

And said account and petition coming on this day regularly to be heard, proof having been made to the satisfaction of this court that due and legal notice of the time and place of settlement of said account and the hearing of said petition having been given in the manner and for the time required by law;

AND it appearing that said account is in all respects true and correct and supported by proper vouchers; said petition is now allowed and all payments are approved by this court, AND

It appearing that all claims and debts against said estate, all taxes of said estate, including the debts and charges of administration, have been fully paid and discharged, and said estate is ready for distribution and in condition to be closed, AND

It further appearing that said Frances Moffat died intestate on the 20th day of December A.D., 1936 and left her surviving as her heirs and only heirs at law:

Now, therefore, on the petition of Geo. A. Moffat, Administrator as aforesaid and on motion of counsel for Administrator and no objections being made thereto,

IT IS ORDERED ADJUDGED AND DECREED that the said final account of said Administrator be made and the same is hereby settled, allowed and approved.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED and this court does hereby order that the residue of said estate of Frances Moffat, deceased, hereinafter particularly described and now remaining in the hands of said Administrator and any other property now or hereinafter discovered and wherever situate, which may belong to said estate or in which the said estate may have any interest, be, and the same is hereby distributed to, and divested absolute in the above named heirs, forever, to have and to hold the same, to the above named persons, their heirs and assigns forever, and in the proportionate part and manner to-wit:

One-half of the whole of the residue of the hereinafter described property to Addison Moffat, husband of said deceased, of Big Piney, Wyoming.

One-Seventh of the whole of the residue of the hereinafter described property to Mrs. Alice R. Bowman, daughter of said deceased, of 1942 Wellington place, Wichita Kansas.

One-seventh of the whole of the residue of the hereinafter described property to Mrs. Laura Ricord, daughter of said deceased of 1942 Wellington Place, Wichita, Kansas.

One-seventh of the whole of the residue of the hereinafter described property to William Moffat, son of said deceased of Big Piney, Wyoming.

One-seventh of the whole of the residue of the hereinafter described property to Mrs. Grace Sage, daughter of said deceased of Big Piney, Wyoming.

One-seventh of the whole of the residue of the hereinafter described property to Mr. John Moffat, son of said deceased of Big Piney, Wyoming.

One-seventh of the whole of the residue of the hereinafter described property to Mr. Frank Moffat, son of said deceased of Big Piney, Wyoming.

One-seventh of the whole of the residue of the hereinafter described property to Mr. George A. Moffat, son of said deceased of Big Piney, Wyoming.

The following is a particular description of the said residue of said estate referred to in this decree and of which distribution is now ordered as aforesaid to-wit:

The South West Quarter of the North East Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$), the North West Quarter of the South East Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$), the North East Quarter of the South East Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$), and the South East Quarter of the North West Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$), all in Section thirteen (13) Township Thirty-one (31)
