EASEMENT OF RIGHT OF WAY FOR WILLOW CREEK SUPPLEMENTAL DITCH.

George Jorgensen, in consideration of the sum of one dollar (\$1.00), receipt whereof is hereby acknowledged, does hereby grant unto Charles J. Bayer, Frank Steele, Ed. Edwards and Fred Ecklund, an easement of Right of Way, over, upon and across the following described land, situated in Sublette County, Wyoming:

SW 1/4 SE 1/4 Sec. 19 T. 34 N.R. 109 W of the 6th P.M.

To have and to use continuously and perpetually, only for the specific purpose of constructing, operating and maintaining an irrigation ditch thereon, the location and extension of which is described as follows:

A Right of Way for the Willow Creek Supplemental Ditch and lateral thereof 30 feet in width, being 15 feet on each side of a center line described by the following survey: Beginning at the South 1/4 corner of Section 19, T. 34 N.R. 109 W, the headgate is located N. 28 45' E. 550 feet. Thence 5 East 525 feet to the South line of Sec. 19, T. 34 N.R. 109 W, of 6th P.M.

It is expressly understood that upon abandonment of the ditch described herein, the right of the said Grantees to the use of said land shall terminate, and all rights conveyed herein shall revert to the Grantor, his heirs, successors and assigns, the same as if this grant had never been made.
