The Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty-seven (27), and the West Half of the Southwest Quarter of the Northwest Quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-five (35), Township Twenty-seven (27) North, Range One Hundred and Thirteen (113) West, containing 60 acres, more or less;

which lease is covered by that certain Operating Agreement dated March 8, 1924, entered into by and between Herschel Bondaurant and George W. Danley, as first parties, and Wyotah Oil & Gas Company, a Wyoming corporation, as second party, filed for record on May 12, 1925, and thereafter duly recorded in Book 1 of Miscellaneous on Page 293 of the records of the County Clerk of said County and State, which Operating Agreement is now owned by California Petroleum Corporation;

which said royalty interests are covered by that certain Assignment of Royalty dated April 9, 1936, from Beneficial Oil Company to California Petroleum Corporation, recorded in Book 3 at Page 360 of the Miscellaneous Records of Sublette County, State of Wyoming;

TO HAVE AND TO HOLD Unto said The Texas Company, its successors and assigns, forever, said royalty interests as above set forth, together with all rights, privileges, and benefits pertaining thereto, as well as all rights, privileges, and benefits under said United States Government leases and the Operating Agreements covering the development of the lands hereinabove described, and said California Petroleum Corporation does hereby covenant and agree that it has good right and lawful authority to sell and assign said royalty interests; that the above described overriding royalty interests are now in full force and effect and are not now subject to cancellation or forfeiture for any reason, and said California Petroleum Corporation against all and every person or persons whomever lawfully claiming or to claim the whole or any part thereof, shall and will warrant and forever defend.

This royalty assignment is subject to the approval of the Secretary of the Interior if and only if such approval is necessary as a matter of law.
