FREE RENTAL AGREEMENT

THIS INDENTURE, made and entered into in Agreement this 17th day of April, A.D. 1940, by  
and between National Livestock Company By L. C. Nelson, President of Boulder, Wyoming, here-  
inafter called the Lessor, and the United States of America, by Grazing District # 5, and the  
Regional Grazier for Region No. 10, Division of Grazing, Department of the Interior, herein-  
after called the lessee, WITNESSETH:

That, for and in consideration of the mutual benefits to be derived from the construct-  
ion and maintenance of a Civilian Conservation Corps side camp, and the desire of the Lessor  
to assist in the work of the Civilian Conservation Corps, the lessor hereby grants and donates  
to the Lessee, without any charge or compensation whatsoever, a leasehold interest for 24  
months, beginning April 20, 1940, and ending April 20, 1942, together with the right of renew-  
al, until June 30, 1942, on the following described lands situated in the County of Sublette,  
State of Wyoming, to-wit:

SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 34 Township 32 North, Range 108 West

The lessee shall have the right to terminate this lease by giving written notice to the  
lessor 30 days prior to such termination. The lessee shall have the privilege of making such  
improvements on said property, as are essential to the successful operation, welfare, and  
maintenance of said side camp, and shall have the privilege of removing from said land, with-  
in ninety (90) days after the termination of this agreement, or any renewal thereof, any and  
all property, buildings, or other structures, or improvements that may have been placed  
thereon by the lessee.

It is understood that the lessee will have for Civilian Conservation Corps purposes and  
for its Division of Grazing personnel, the right of access to said lands by existing road-  
ways and trails over adjoining lands owned by the lessor, and to improve and repair such  
roadways and trails, and to take from East Fork Creek located about 100 feet from said camp-  
site, sufficient water needed in conducting said camp, together with the right of way for a  
pipe line from said East Fork Creek to the campsite, and to use, from lands in the vicinity  
of the campsite, down and standing dead-timber for firewood and other camp purposes.

The lessee agrees to commit no waste on any of the premises of the lessor and to return  
all premises within ninety (90) days from the termination of this agreement, or any renewal  
thereof, together with any roads or trails over lands of the lessor used by the lessee in a  
good state of repair and in as good condition as they now are, damage from acts of God ex-  
cepted.
