KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, by Oil and Gas Lease in writing, bearing date the 16th day of January, 1940, Philetus P. Twichel and Isabelle Twichel, as first parties, leased and demised to Arthur D. Jett and Charles Lackey, as second parties, the following described land, situate in Sublette County, Wyoming, to-wit:

The S<sub>1/4</sub>SW<sub>1/4</sub> of Section 33, and SE<sub>1/4</sub>SE<sub>1/4</sub>, Section 32, Township 27 North, Range 113 West 6th Principal Meridian, Wyoming; and

WHEREAS, said first parties deem that the obligation of second parties under said Oil and Gas Lease has been breached, and it is, therefore, deemed expedient by both first parties and second parties that the rights in and under said Oil and Gas Lease be further fixed and defined: Now, Therefore,

The said first parties, for and in consideration of the sum of One Dollar to them in hand paid by second parties, do, by these presents grant and extend the term of said Oil and Gas Lease for an additional term of sixty (60) days, from and after the first day of January 1941, until and including the first day of March, 1941, within which to comply with all the terms and conditions of said Oil and Gas Lease.

Provided, nevertheless, that if, on or before the first day of March, 1941, said second parties, their heirs or assigns, shall not have fully complied with all the terms and conditions of said Oil and Gas Lease, then and in that event, said Oil and Gas Lease, and all the terms and conditions thereof, and all rights of said second parties, their heirs and assigns therein, and in or to said above described lands, and every part thereof, shall terminate and be ended, without notice to second parties, and first parties shall thereupon re-enter into said lands, and every part thereof, as in their first and former estate.
