Dear Sir:

In view of the fact that you have not complied with the conditions of Oil and Gas Lease dated June 1, 1939, made by and between Al Osterhout and Sadie Osterhout, his wife, as Lessor, and H. E. Ewart as Lessee, for the drilling of an oil and/or gas well upon lands described as:
