AMENDED FINAL DECREE AND DETERMINATION OF HEIRSHIP

THIS MATTER came on to be heard by the Court, sitting in probate, upon the Petition of the executor for an Amended Decree and Determination of Heirship in said estate; and it appearing to the satisfaction of the Court that the Letters Testamentary issued to said executor have not been revoked and that said estate has not been closed and that said executor has not been discharged; and it further appearing to the satisfaction of the Court that the Final Decree, made and entered herein on October 19, A. D. 1938, does not set forth the names of the heirs of said testator and that the Court has not made a determination of the heirship;

And the Court having heard the Petition of said executor and having heard the evidence adduced herein and being now sufficiently advised in the premises, doth say and find that the said Alfred A. Miller, during his lifetime, filed and made entry on government lands, specifically described in the Petition herein filed, and that a Patent for said lands was issued on the 12th day of February, A. D. 1940, by the United States of America, to "The heirs of Alfred A. Miller", deceased;

And the Court further finds that the allegations contained and set forth in the Petition, herein filed, are true, and that the persons named therein are the heirs and next of kin of the said Alfred A. Miller, deceased.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the said Alfred A. Miller, deceased, died leaving a Last Will and Testament, and that said Last Will and Testament has been admitted to probate, and that said testator left surviving, as his only heirs at law and next of kin, the following named persons, to-wit: James Miller, brother of decedent, age over 21 years, residence 209 Logan Street, Rock Springs, Wyoming; Claude C. Miller, brother of decedent, age over 21 years, residence Lander, Wyoming; John C. Miller, brother of decedent, age over 21 years, residence Boulder, Wyoming; Minnie Baker, sister of decedent, a widow, age over 21 years, residence Salt Lake City, Utah; Maude Washam, sister of decedent, age over 21 years, residence Boulder, Wyoming; Elvena Hallett niece of decedent, age over 21 years, residence California; Florence Mae Hallett, niece of decedent, age over 21 years, residence California; and William Hallett Jr. nephew of decedent, age over 21 years, residence, Denver, Colorado. and said persons being the brothers and sisters nieces and nephew of deceased are hereby determined and decreed to be his heirs at law and next of kin, and as such, are entitled to share in his estate or any part thereof which has not been given, bequeathed and devised by his Last Will and Testament.
