IN THE MATTER OF THE PETITION OF FRED EKLUND FOR AN AMENDED CERTIFICATE OF APPROPRIATION FOR AN APPROPRIATION OF WATER FROM POLE CREEK, TRIBUTARY OF WEST FORK OF NEW FORK RIVER, THROUGH THE POLE CREEK DITCH NO. TWO, UNDER PERMIT NO. 1875 ENL. WITH PRIORITY OF MAY 21, 1908, AS ADJUDICATED IN THE NAME OF FRED C. EKLUND. (O.R. 4, P. 449; C.R. 32, P. 26, PROOF 10872).

FINDINGS AND ORDER

THIS MATTER coming regularly before the State Board of Control this 17th day of April, 1941, the Board FINDS:

THAT the petitioner, Fred Eklund, sets forth under oath that he is the sole owner of an appropriation of water from Pole Creek, tributary of West Fork of New Fork River, diverted through the Pole Creek Ditch No. Two under Permit No. 1875 Enl. with priority of May 21, 1908, as adjudicated in the name of Fred C. Fisher (O.R. 4, P. 449; C.R. 32, P. 26; Proof No. 10872) and of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 4, Township 33 North, Range 108 West;

THAT the adjudication of this appropriation of water as of record in Order Record 4, Page 449, and the Certificate of Appropriation issued thereunder, described the lands to be irrigated as:

15 Acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4
20 Acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
20 Acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 9, all in Township 33 North, Range 108 West;

THAT the original Order of adjudication and the Certificate of Appropriation issued thereunder are in error as to the description of the irrigated lands on which the appropriation of water has been applied and the petitioner requests an Amended Certificate of Appropriation be issued to him to correctly describe the lands as follows:

15 Acres NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4
20 Acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
20 Acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 9, Township 33 North, Range 108 West;

THAT a certificate of the County Clerk of Sublette County, showing Fred Eklund to be the owner of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 4, and the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 9, Township 33 North, Range 108 West, accompanies the petition;

THAT a letter from the Register of the United States Land Office at Evanston, Wyoming, showing the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 9, Township 33 North, Range 108 West to be vacant government land, accompanies the petition;

THAT Permit No. 1875 Enl. and the map accompanying the said permit show the 15 acres to be located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 4, Township 33 North, Range 108 West, and the error was caused by the land being erroneously described in the proof originally submitted;

THAT no maps are filed as the error is clearly a clerical one.

The Board, having considered the petition and being advised by the records of the office of the State Board of Control and the showings presented in the matter, THEREFORE ORDERS:

THAT the petition be GRANTED;
