KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the undersigned, Clarence I. Justheim, is the present holder and owner of an undivided one-fourth (1/4) interest in and to the following applications for oil and gas leases from the United States of America, namely: Evanston 021065, Evanston 021066, and Evanston 021075 on the following described land, to-wit:

Section 34; S1/4, S1/4NW1/4 Section 27; S1/4, S1/4NW1/4 Section 26; Section 35; S1/4, S1/4NE1/4 Section 25, Township 29 North, Range 113 West.

Sections 1, 2, 3, 4, 9, 10, E1/4, E1/4NW1/4, NW1/4NW1/4 Section 5, Township 28 North, Range 113 West, 6 P. M., Sublette County, Wyoming.

NOW, THEREFORE, in consideration of \$10.00 and other good and valuable considerations, the receipt of which is hereby acknowledged, the undersigned does hereby sell, assign and transfer to (Mrs.) Lesley D. W. Riter an undivided one-fifteenth (1/15th) of the one-fourth (1/4) interest in and to all the oil and gas or other hydrocarbons produced and sold from the above described lands, during the term of the present subsisting applications Evanston 021065 and Evanston 021066, & 021075, subject only to the following charges and interest:

1. Royalties due and payable to the United States of America.
2. The pro rata share of all taxes and assessments on minerals levied by Federal, State, County, or City Government or any subdivision thereof which may be charged against said property hereinabove described or the products thereof.
3. The costs of drilling, operating and producing from said land. It is agreed that the Assignor and the Assignee will each contribute 10% of the net returns from all oil and gas produced and sold from their respective interest to a drilling fund to be used for the drilling and operating of the wells to be drilled and operated under the terms of the leases and operating agreements covering the above described land. This 20% drilling fund contributed by the Assignor and Assignee shall be made payable direct from the oil purchaser to two Trustees to be nominated in writing, one by the Assignor and one by the Assignee. Said Trustees to take, hold, and expend said drilling fund under a Trust Agreement to be executed by the Assignor and Assignee and the other holders of counterpart assignments. Both parties hereto agree to execute an assignment authorizing the said oil purchaser to pay said 10% of net returns to said Trustees. This contribution of 10% by both parties shall continue so long as drilling requirements shall make it necessary.
