

gas produced and sold from their respective interests to a drilling fund to be used for the drilling and operating of the wells to be drilled and operated under the terms of the leases and operating agreements covering the above described land. This 20% drilling fund contributed by the Assignor and Assignee shall be made payable direct from the oil purchaser to two Trustees to be nominated in writing, one by the Assignor and one by the Assignee. Said Trustees to take, hold, and expend said drilling fund under a Trust Agreement to be executed by the Assignor and Assignee and the other holders of counterpart assignments. Both parties hereto agree to execute an assignment authorizing the said oil purchaser to pay said 10% of net returns to said Trustees. This contribution of 10% by both parties shall continue so long as drilling requirements shall make it necessary.
