Matt Bertagnolli of Kemerer, Wyo. are citizen of the United States, over the age of
twenty-one years and residing in the County of Summit and State of Utah having discovered a
vein or lode of quartz, or rock in place, bearing East & West within the circuit or claim
hereby located, claim by right of discovery and location, under and in accordance with the
