Agreement made in the City of Rock Springs, Wyoming, on the 11 day of October, 1941, between A. W. Travelute, party of the first part, hereinafter called the vendor, and Alice J. McLain, party of the second part, hereinafter called the purchaser, witnesseth:

1. The vendor hereby agrees to sell and convey, and the purchaser agrees to purchase, all that certain tract of land, with the buildings and improvements thereon, situate in the County of Sublette, State of Wyoming, and described as follows:

2. The purchaser, in consideration of the mutual promises and agreements of the vendor hereinafter set forth, agrees as follows:

a. To pay \$10.00 per acre, of which \$5000.00 as a deposit is now paid, the receipt of which by the vendor is hereby acknowledged, and the balance to be paid upon delivery of title and possession.

3. The vendor, in consideration of the aforesaid promises and agreements of the purchaser, hereby agrees as follows:

a. To furnish and deliver to the purchaser a properly certified abstract of title to the premises described in paragraph 1 hereof.

b. To convey and assure to the purchaser, clear of all incumbrances whatsoever, by a good and sufficient Bill of Sale, the personal property described in the attached inventory sheet, marked Exhibit "A" and made a part hereof.

c. To convey and assure to the purchaser, in fee simple clear of all incumbrances whatsoever, by a good and sufficient Warranty Deed, the property described in paragraph 1 hereof.

4. It is further agreed that the vendor will pay all taxes assessed or levied prior to January 1, 1942, against the property conveyed by him to the purchaser.
