DECREE OF SETTLEMENT OF ACCOUNT AND FINAL DISTRIBUTION

ELIZABETH LINDBACK, as the executrix of the last will and testament of Ludvig Lindback, deceased, having on or before the 24th day of April, 1942, rendered and filed herein a full account and report of her administration of said estate, which account was for a final settlement, and having with said account presented and filed a petition for the distribution of the estate of said deceased;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the court that due and legal notice of the time and place of the settlement of said account, and the hearing of said petition had been given in the manner and for the time required by law;

And it appearing that said account is in all respects true and correct, and that it is supported by proper vouchers; that since the rendition of said account no moneys have been received by said executrix, and that the money in her hands for distribution is the sum of \$1634.09.

And it appearing that all claims and debts against said decedent, all taxes on said estate, including inheritance taxes, and all debts, expenses and charges of administration have been paid and that said estate is ready for distribution and in condition to be closed;

And it further appearing that said Ludvig Lindback died testate in the County of Lincoln State of Wyoming on the 23 day of March, 1941, a resident of Sublette County, and in the State of Wyoming, and that by the last will and testament of said decedent, duly admitted to probate in this court, said decedent devised and bequeathed the whole of his said estate to Elizabeth Lindback, his surviving widow.

NOW, THEREFORE, on the petition of said Elizabeth Lindback, executrix of the last will and testament of said Ludvig Lindback, deceased, and on motion of counsel for said executrix, and no objections being made thereto, it is hereby, by the court duly

CONSIDERED, ORDERED, ADJUDGED and DECREED, that the said final account of said executrix be, and the same is hereby settled, allowed and approved; and it is further, by the court

CONSIDERED, ORDERED, ADJUDGED and DECREED, that the residue of the estate of said Ludvig Lindback, deceased, hereinafter particularly set forth and described and now remaining in the hands of said executrix, and all other property not now known or discovered which may be long to said estate, or in which said estate may have any interest, be, and the same is hereby assigned, set over, distributed and vested absolutely in the person entitled thereto by the terms and provisions of the said will and testament of said decedent, in the manner following, that is to say:

The whole of the residue of said estate, both real and personal, to the said ELIZABETH LINDBACK, to have and to hold the same unto her, the said Elizabeth Lindback, her heirs and assigns forever, being subject, however, to any and all unsatisfied mortgages of record against said property.

The following is a particular description of the said residue of said estate referred to in this decree and of which distribution is now ordered, adjudged and decreed to the Elizabeth Lindback, as aforesaid, to wit:

REAL PROPERTY

The South-half of the South-half ($S\frac{1}{2}S\frac{1}{2}$) of Section Twenty (20); the South east quarter of the Northwest quarter ($SE\frac{1}{4}NW\frac{1}{4}$), the Southwest quarter of the Southwest quarter ($SW\frac{1}{4}SW\frac{1}{4}$), the Northeast quarter of the Southwest quarter ($NE\frac{1}{4}SW\frac{1}{4}$), and the North-half of the Southeast quarter ($N\frac{1}{2}SE\frac{1}{4}$), of Section Twenty-one (21); the Southwest quarter ($SW\frac{1}{4}$) and the Southwest quarter of the Southeast quarter ($SW\frac{1}{4}SE\frac{1}{4}$) of Section Twenty-two (22); the North-half ($N\frac{1}{2}$) of the Northwest quarter ($NW\frac{1}{4}$) of Section Twenty-seven (27); the Northwest quarter of the Northwest quarter ($NW\frac{1}{4}NW\frac{1}{4}$) of Section Twenty-eight (28); the North-half of the North-half ($N\frac{1}{2}N\frac{1}{2}$) of Section Twenty-nine (29) and the Lots One (1), Two (2), Three (3) and Four (4) and the East -half ($E\frac{1}{2}$) and the East-half of the West-half ($E\frac{1}{2}W\frac{1}{2}$) of Section Eighteen (18), all in Township Thirty-three (33) North Range One Hundred Thirteen (113) West of the Sixth Principal Meridian, Wyoming; also,

The Southwest quarter of the Southwest quarter of Section Fifteen (15); the Northwest quarter of the Northwest quarter ($NW\frac{1}{4}NW\frac{1}{4}$), the South-half of the North-half ($S\frac{1}{2}N\frac{1}{2}$) and the Northeast quarter of the Northeast quarter ($NE\frac{1}{4}NE\frac{1}{4}$) of Section Twenty-two (22); the North-half ($N\frac{1}{2}$) of Section Twenty-three (23); the Southeast quarter of the Southwest quarter ($SE\frac{1}{4}SW\frac{1}{4}$), and the Southeast quarter ($SE\frac{1}{4}$) of Section Fourteen (14), and the South-half ($S\frac{1}{2}$) of Section Thirteen (13), all in Township Thirty-three (33) North, Range One Hundred Fourteen (114) West of the Sixth Principal Meridian, Wyoming.
