DECREE OF SETTLEMENT OF ACCOUNT AND  
 FINAL DISTRIBUTION.

SADIE OSTERHOUT, as the Executrix of the last Will and Testament of AL OSTERHOUT, deceased, having on or before the 5th day of June, 1942, rendered and filed herein a full account and report of her administration of said estate, which account was for a final settlement, and having with said account presented and filed her petition for the final distribution of said estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the court that due and legal notice of the time and place of the settlement of said account and the hearing of said petition had been given in the manner and form required by law and duly published for the time provided by statute;

And it appearing that said account is in all respects true and correct, and that said executrix, as the surviving widow of said deceased, has paid all claims and debts against said deceased, and that all taxes, including inheritance taxes, and all debts, expenses and charges of administration, and all funeral expenses and the expenses incurred in the last sickness of decedent have been fully paid and discharged by her, and that said estate is ready for distribution and in condition to be closed.

And it further appearing that the said decedent, Al Osterhout, died testate, and by the last Will and Testament of said decedent, duly admitted to probate in this court, said decedent devised and bequeathed the whole of his estate to his said widow, SADIE OSTERHOUT.

Now, therefore, on the petition of SADIE OSTERHOUT, executrix aforesaid, and on motion of counsel for said executrix and no objections being made thereto, it is hereby, by the court duly

CONSIDERED, ORDERED, ADJUDGED and DECREED, that the said final account of said executrix be, and the same is settled, allowed and approved; and it is by the court further

CONSIDERED, ORDERED, ADJUDGED and DECREED, that the residue of the estate of said Al Osterhout, deceased, hereinafter particularly mentioned and described now remaining in the hands of said executrix, and any all other property not now known or discovered, or omitted herein, which may belong to said estate, or in which the said estate may have any interest, and the whole thereof be, and the same is hereby assigned, distributed and absolutely vested in the person entitled thereto by the terms and provisions of the said aforementioned last will and testament of said decedent, that is to say:

The whole thereof to the said SADIE OSTERHOUT.

The following is a particular description of the estate of said decedent, Al Osterhout referred to in this decree and of which distribution is now ordered and decreed, as aforesaid, to-wit:

REAL PROPERTY. The Lots One (1), Two (2), Three (3) and Four (4) and the East-half of the Southwest quarter (E $\frac{1}{2}$ SW $\frac{1}{4}$ ) of Section Thirty (30) in Township Thirty-one (31) North, Range One Hundred Thirteen (113) West of the Sixth Principal Meridian, in Wyoming, also the South-half (S $\frac{1}{2}$ ) and the Southeast quarter of the Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Twenty-five (25) in Township Thirty-one (31) North, Range One Hundred Fourteen (114) West of the Sixth Principal Meridian, Wyoming, containing in all 612.16 acres; also

The Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Twenty (20); the South-half of the Southwest quarter (S $\frac{1}{2}$ SW $\frac{1}{4}$ ) of Section Twenty-one (21), and the East-half of the East-half (E $\frac{1}{2}$ E $\frac{1}{2}$ ) of Section Twenty-nine (29), in Township Thirty-one (31) North of Range One Hundred Thirteen (113) West of the Sixth Principal Meridian, in Wyoming, containing 480 acres.
