The First National Bank of Kemmerer, Wyoming, as executor of the will of Albert Hill, deceased, in consideration of six hundred dollars cash, receipt of which is hereby acknowledged, does hereby grant and convey to Richard G. Dew and Cornelia L. Dew, husband and wife, and Theodore R. Dew and Elysabeth B. Dew, husband and wife, all of the right, title and interest of the said decedent at the time of his death, and all of the right, title and interest that the estate may have subsequently acquired by operation of law, or otherwise, in and to the real property situated in the county of Sublette, state of Wyoming, described as follows, to-wit:

Section sixteen, township thirty-seven north, range one hundred ten west of the sixth principal meridian;

And the First National Bank of Kemmerer, Wyoming, as executor of the will of Albert Hill, deceased, for the consideration aforesaid, does hereby sell, assign, transfer and set over to said grantees all of the right, title and interest of said decedent at the time of his death, and all of the right, title and interest that the estate may have subsequently acquired by operation of law, or otherwise, in and to that certain lease of the aforesaid land numbered 3 - 4166, expiring March 1, 1949, in which the State of Wyoming is lessor and the said Albert Hill is named as lessee;

Reference is hereby made to the order rendered by the district court of the state of Wyoming in and for the county of Sublette, and the proceedings had, in the matter of the estate of Albert Hill, deceased, and particularly to the order confirming sale and directing conveyance of real and personal property, dated May 15, 1942, a certified copy of which order was filed in the office of the County Clerk and Ex-officio Register of Deeds, of said Sublette County, Wyoming, on May 18, 1941, and recorded in Book 9 of Miscellaneous, page 43, and reference is hereby made to said order and recordation thereof, and this deed is given pursuant to said proceedings and order.
