The above entitled action now coming on before the Court upon the Stipulation filed herein this day, the plaintiff being represented by P. W. Spaulding, his attorney, and the defendants being represented by G. B. Hockett, their attorney, and they waiving time to answer or plead, and said stipulation being presented to and considered by the Court, it is therefore upon hereby

Ordered, adjudged and decreed that said defendants, on or before October 1st, 1942, surrender possession of and deliver to the plaintiff, his attorney or agent, the property real and personal described in the agreements alleged in the petition herein and mentioned in said stipulation, and the fixtures and improvements thereon, subject to the use and wear heretofore made thereof, and possession of the frame house erected of the boiler and mentioned in said stipulation, subject to the taxes on said property for the years 1941 and 1942, and the claim of Charles Wiederanders for payment for said frame building, AND

Thereupon the said defendants and each of them be and they hereby are released and discharged from any and all further liability to plaintiff upon said agreements or either of them and all rights of said defendants, or either of them, under said agreements, or any of them, be and they hereby are terminated, canceled and ended and that all payments made by them on said agreements to said plaintiff be retained by him, AND

That three of said agreements are of record in the office of the County Clerk of said Sublette County, Wyoming, in Book 5 of Miscellaneous Record at pages 54, 56, and 60, and a copy of this Judgement, certified as to be, be filed in said office and noted on said agreements, AND

This Court retain jurisdiction of this action for consideration and entry of such other and further orders as may become necessary or proper herein.
