

KNOW ALL MEN BY THESE PRESENTS:

That Vigo N. Miller and Iona R. Miller, his wife, of Daniel, Sublette County, Wyoming, the Vendors for and in consideration of ten dollars and other valuable and adequate consideration in hand paid, hereby bargain, sell and convey and deliver unto Albert E. Schwabacher and May K. Schwabacher, his wife, of San Francisco, California, and the survivor thereof, the vendees, the following goods and chattels:

One herd of approximately 2250 head of ewe sheep and 426 head of their 1942 lambs, and 60 head of bucks and one sheep camp wagon outfit and equipment, horses, harnesses, saddles and other equipment used in the operation and running of said sheep, but not including the supplies therein payment for which is to be made in addition to the above amount.

One bull, 30 and more head of cattle, and 60 and more head of horses being all the cattle and horses owned by the vendors and run on or in connection with their ranch properties in Sublette County this day conveyed by the vendors to the vendees, but except three saddle horses to be selected and retained by the vendors.

All hay grown and stacked on the ranch property of said vendors in sections 5 and 6, township 33 north, range 110 west and sections 31 and 32, township 34 north, range 110 west and south half of section 36 in township 34 north, range 111 west, in said Sublette County, and this day conveyed as aforesaid, also all hay grown and stacked on what is known as the Cochrane lease adjoining said sections 5 and 6.

1 McCormick-Deering tractor, 1 International pick-up 5 wagons, 3 side delivery rakes, 2 Model A trucks, 2 McCormick-Deering mowers, 2 horse sweeps, 1 power sweep, 1 hay bailer, 1 wood sawing outfit, 1 seeder, 1 tractor plow, 1 bull dozer, 1 lot blacksmith shop equipment and tools, 10 or more sets of harness, and all ranching machinery, equipment, implements and tools of the vendors used in the operation of the ranching business conducted on said premises. All household goods, furniture, furnishings and effects and kitchen and table ware and cooking utensils in the dwelling on said premises, and lighting plant and fixtures; except keepsakes, personal effects, piano, living room furniture and home-made bed set, mattress and springs as listed, understood and agreed between said Iona R. Miller and May K. Schwabacher.
