I, R. S. Carlson, the duly elected, qualified and acting Sheriff of Sublette County, State of Wyoming, being first duly sworn on my oath, do depose and hereby certify:

That at the hour of 2 o'clock in the afternoon on the 20th day of February, A. D., 1943, at the front door of the Court House, of the County and State aforesaid, in the town of Pinedale, the same being the place of holding the District Court in the aforesaid County. I did offer for sale at public auction to the highest and best bidder for cash, at said time and place, and sold the same to Dennis V. Chall, the Plaintiff in this action, she being the highest and best bidder, for the sum of One Thousand One Hundred Twenty and no/100 (\$1,120.00) Dollars, that being the highest and best big; the following described premises, tenements and real estate situate in the aforesaid County and State, to-wit:

The North-half of the North-half ($\frac{1}{2} \times \frac{1}{2}$) of Section nine (9), Township thirty-four (34) North, Range 113 West, 6th Principal Meridian, Sublette County, Wyoming, together with all improvements, ditches, dykes, water and water rights thereunto appertaining.

And I further certify that said premises were sold under and by virtue of that certain Decree and Order of Sale rendered by the Honorable H. R. Christmas, Judge of the District Court in and for the County of Sublette, State of Wyoming, on the 14th day of January, 1943, in favor of Dennis V. Chall, Plaintiff, and against Wm. C. Chall & Dennis V. Chall, Defendants, and wherein it was further considered, ordered, adjudged and decreed that the Defendants should be forever barred and foreclosed from all equity of redemption or claim to or interest in the above described premises, save and except as by Statute provided, which said Decree was given the 14th day of January, 1943, in the total sum of One Thousand Two Hundred Eighty-seven and no/100 (\$1,287.00) Dollars, together with interest at the rate of 7 per cent per annum from said date, of said Decree.

I hereby further certify that I did cause notice of said sale to be published for four consecutive weeks in the Pinedale Roundup, a weekly newspaper of general circulation, published weekly at Pinedale, in the County and State aforesaid, the first publication of said notice having been made January 21, 1943, the last publication having been made on the 11th day of February, 1943, and that all acts had and done in this matter were according to and conforming to the requirements of law in such cases made and provided. Notice of such sale and publishers affidavit of same are filed in this action, with the Clerk of the Court of this County.
