DECREE AND ORDER

This matter coming on regularly to be heard this 8th day of September, A. D. 1941, upon the petition of Zeda Roop, administratrix of the estate and widow of Milbrey Roop, deceased, praying for an order setting over to her as her absolute property all the property of said decedent, both real and personal; proof having been made to the satisfaction of this Court that due notice of this hearing has been regularly given as required by law; and no cause being shown or no objections made why all of said property should not be set over to the said widow; and the Court having heard all the evidence adduced, doth find:

That all of the property of said estate, hereinafter particularly described, is of a net value of less than Two Thousand Five Hundred and no/100 (\$2,500.00) Dollars, and is exempt from execution under the exemption laws of this State; that the same should be set over to the said widow as her absolute property, subject however to all prior liens.

The Court doth further find that all taxes, including State Inheritance Tax, costs of administration, last sickness and funeral expenses have all been paid. IT IS THEREFORE

ORDERED, ADJUDGED, AND DECREED that all that real and personal property hereinafter described, as follows, to-wit:

The Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$), the North Half of the Southeast Quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$), the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$), and the East Half of the Northwest Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) of Section Twenty-six (26), Township Thirty-three (33) North, Range One Hundred Eight (108), West of the Sixth (6th) Principal Meridian, Wyoming, together with all water and water rights, ditches, dykes, dams, buildings, improvements, and everything thereunto appertaining and/or belonging

PERSONAL PROPERTY:

Cash on hand in the sum of Three Hundred Ninety-five and no/100 (\$395.00) Dollars;
 Ten (10) head of cows and calves; Fourteen (14) head of cows, Seventeen (17) head of yearlings (All the cattle are branded ω on the left rib with the following exceptions: One (1) cross breed, black, branded AHN on left rib; One (1) Hereford cross, black with white face, branded A on left rib; One (1) red and white spotted cow, branded L on left rib; One (1) Hereford bull branded $\frac{1}{2}$ on left hip.);
 One Hundred (100) head of sheep branded ω on left rib;
 Ten (10) head of horses (All branded ω on left thigh, except one (1) graymare, grade, branded \square .);
 Miscellaneous farm implements and machinery; One (1) saddle; One (1) 1937 Dodge 4-door Sedan, Motor No. D5-267-537; Serial No. 4784454; and Three (3) sacks of wool, weighing approximately 1,500 lbs;

be and the same is hereby set over to Zeda Roop, for the use and bene fit of said widow and as her absolute property; AND

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that no further proceedings shall be required in the administration of this Estate unless further estate be discovered; and it is further ordered that a certified copy of this order be recorded in the office of the County Clerk and Ex-Officio Register of Deeds of Sublette County, Wyoming.
