It is agreed that this instrument or a certified copy thereof shall constitute authority to the holder of the oil and gas lease covering the above described land or any purchaser of the oil and/or gas produced therefrom, to pay to H. E. Raddatz, his heirs, personal representatives or assigns, the royalties due the Assignee under this Assignment.
