And I, the Assignor, do hereby represent to the said Assignee, as follows:

That I am over the age of twenty-one (21) years.

That I have not heretofore assigned or transferred my interest in the estate of the said Charles Bird, deceased, or any part thereof.

And I, the said Assignor, hereby appoint the said Assignee to be my true and lawful attorney, irrevocable, for me, and in my name and stead, but for such Assignee's own benefit, and at said Assignee's own cost and expense, to demand, sue for, attach, levy, recover and receive any and all sums of money that now are, or hereafter shall become, due, owing and payable under, or by virtue of, the foregoing assignment, and/or the chose in action therein described, with full power and authority to sell, assign, transfer, set over, pledge, compromise, or discharge, the whole, or any part thereof, and to do any and all other acts and things necessary, or proper, to accomplish the foregoing purposes, or any of them, hereby ratifying and confirming all that my said attorney, or his substitute shall, or may, lawfully do, or cause to be done, by virtue hereof.
