That the undersigned, W. Russell Hull, of Salt Lake City Utah, is the lessee under an oil and gas lease issued by the United States upon application Serial No. 021585 in the U. S. Land Office at Evanston, Wyoming, covering among other lands the 160 acres located and described as follows:
