KNOW ALL MEN BY THESE PRESENTS, That we A. E. Stirrett, Hal Curran and R. H. Nichols, the undersigned, all citizens of the United States of America and residents of the City of Casper, County of Natrona, State of Wyoming, have associated ourselves together as a body corporate and politic under the laws of the State of Wyoming, and have executed this Certificate of the Articles of Incorporation of the herein named company, in duplicate, as such body corporate and politic, and do hereby certify that:

One. The name of said corporation is and shall be "HALF MOON LODGE."

Two. The term of existence of said corporation shall be fifty years next after the 12th day of May, A. D. 1922.

Three. The principal purpose and object of said company shall be to conduct a general pleasure resort business in all its branches in the State of Wyoming, and in such other states, territories or possessions of the United States of America as may be determined upon by the stockholders or the board of directors. In the conduct of said general business said company may acquire all kinds of property, real, personal and mixed, and interests therein of every kind and character whatsoever, and may own, build upon, improve rent, operate, handle, incumber, develop, dispose of or in any way use the said property and in connection with the conduct of such general business in all its branches said company may perform and conduct all such subsidiary operations and do all such lawful things as are necessary or incidental to the successful prosecution of the main purpose of said company.

Four. The capital stock of said corporation shall be Ten Thousand (\$10,000.00) Dollars, divided into one hundred (100) shares of the par value of One Hundred (\$100.00) Dollars per share, which said capital stock shall be issued fully-paid and non-assessable and may be and become so fully-paid upon conveyance to, or receipt by, said corporation, of property, money or other assets which, in the opinion of the board of directors of said corporation, is or are, reasonably of the par value of said capital stock so issued therefor, or thereabove in value.

Five. The affairs and management of said corporation shall be under the control of a board of five directors, to be elected annually at the regular annual meeting of the stockholders of said corporation, the time of the holding of which shall be fixed by the by-laws of said corporation, and the five directors of said corporate board for the first corporate year of said company and thereafter until their successors shall have been duly elected and qualified, are and shall be J. T. Scott, J.W. Johnson, A.E. Stirrett, R. H. Nichols and C. B. Wagner. Said board, except as noted in the by-laws of said corporation shall have full control of the property, assets, business and management of said corporation, with full power, except as noted in said by-laws to deal with said property, assets and business and to manage the same, upon such terms and in the manner as to said board shall appear for the best interest of said corporation.

Six. The county of said state in which the principal operations, business and affairs of said corporation shall be conducted, is the County of Natrona, State of Wyoming, and the principal place of business of said corporation is and shall be the City of Casper, said County of Natrona, said State, in which city the principal office of said corporation is and shall be located, but the operations of said corporation may be carried on in such other counties of said state, and without said state, as said board of directors may from time to time designate, upon due compliance with law, and said corporation may establish such other offices either within or without said state, as said board of directors may from time to time designate.
