

And it appearing to the Court that said account is in all respects true and correct, and that it is supported by proper vouchers; that the residue of the money in the hands of the executors at the time of the filing of said account was \$54,239.01; that since the rendition of said account there has been received by said executors the sum of \$ 1654.89; That the sum of \$99,075.77 has been expended by them as necessary expenses of administration, and that the sum of \$40,000.00 has been invested by said executors in United States War Bonds, the vouchers whereof, together with a statement of such expenses and disbursements have been presented and filed herein, and said statement is now settled and allowed, and the payments are approved by this Court: that no further disbursements will be required in the closing of said estate, leaving a residue of \$55,893.90;

And it appearing that all claims and debts against said decedent, all taxes on said estate, including the state inheritance tax, and all debts, expenses and charges of administration have been fully paid and discharged, and that said estate is now ready for distribution and in condition to be closed:

And it further appearing to the Court that the said Mildred O. Mickelson Jensen died testate on the 24th day of August, 1943, and that by the will of said decedent, which was duly admitted to probate herein on the 28th day of October, 1943, said decedent devised and bequeathed the residue of her estate, as follows:

TO ALBERT LARSON "All the lots and improvements thereon presently owned by decedent in the C.P. MacGlashan's First Addition to the Town of Big Piney, Sublette County, Wyoming.

TO JAMES F. MICKELSON and MILDRED MICKELSON MILLER, the entire residuum of said estate except the special devise to ALBERT LARSON,

NOW, THEREFORE, on the petition of said ALBERT LARSON AND JAMES P. JENSEN, EXECUTORS as aforesaid, and on motion of counsel for said executors, and no objections being made thereto, it is hereby, by the Court, duly

CONSIDERED, ORDERED, ADJUDGED AND DECREED, that the said final account of the said executors be, and the same is settled, allowed and approved.

It is further CONSIDERED, ORDERED, ADJUDGED and DECREED by the Court, that the residue of the estate of MILDRED O. MICKELSON JENSEN, DECEASED, hereinafter particularly described and now remaining in the hands of said executors, and any and all other property not now known or discovered which may belong to the said estate, or in which said estate may have any interest be, and the same is hereby assigned, distributed and title therein and thereto absolutely vested in the persons entitled thereto in accordance with the wishes of said decedent as expressed by her will duly admitted to probate herein, as follows, to-wit:

TO ALBERT LARSON, the Lots Numbered Twelve and Thirteen of Block Numbered Fourteen, and the Lots Numbered Six, Seven, Eight, Nine and Ten in the Block Numbered Nineteen, and also all that plat of ground shown on recorded plat of C. P. MacGlashan's First Addition to the town of Big Piney, and named "Piney Drive", which lies north of and contiguous to the Block Numbered Nineteen in said addition and being approximately forty feet wide by two hundred fifty feet long, all the above lots and plat of ground in C. P. MacGlashan's First Addition to the Town of Big Piney, Sublette County, Wyoming, together with the buildings and improvements thereon.

TO JAMES F. MICKELSON, an undivided one-half part and interest in and to the residue of said estate hereinafter particularly described, and

TO MILDRED MICKELSON MILLER, an undivided one-half part and interest in and to the residue of said estate hereinafter particularly described:

The following is a particular description of the said residue of said estate referred to in this decree, and of which distribution is now ordered as aforesaid, to-wit:
