This matter coming on to be heard this day upon the Petition of James M. Payne, Administrator of the estate of Eva M. Payne, deceased, praying for an order setting over to James M. Payne, husband of said deceased, as his absolute property, all of the property of said deceased, and proof having been made to the satisfaction of the Court that due notice of this hearing has regularly been given as required by law, and no cause being shown or objections made why all of the property of the estate of said deceased should not be set over to the said James M. Payne, and the Court having examined the records and files in said cause and being now advised in the premises FINDS:

That all of the property of said estate more particularly hereinafter described, is of a value of less than \$2500.00, and is exempt from execution under the exemption laws of this State, including the Homestead, and that the same should be set over to said James M. Payne as his absolute property, and all singular the law, the evidence and the premises being heard, seen and understood by the Court;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that all of the following described property, both real and personal, situate and being in the County of Sublette, State of Wyoming, be, and the same is hereby set over to James M. Payne, the surviving Husband of said Deceased, as his absolute property, and to his heirs and assigns forever, and that no further proceedings shall be required in the Administration of said estate unless further estate be discovered.
