THIS AGREEMENT, made and entered into this 16th day of October, 1944, between Joe Kramer, a single man, party of the first part hereinafter called the seller, and Harry D. Turner and Elmer E. Turner, parties of the second part, hereinafter called the purchasers, witnesseth:

1. The seller, in consideration of the sum of Three Thousand One Hundred Forty-Five and 00/100 (\$3,145.00) Dollars, to be paid as hereinafter provided, hereby agrees to sell to the purchasers the following described property, to-wit:

Lots Two (2), Three (3) and Four (4), and the South Half of the Northwest quarter (SW $\frac{1}{4}$), Southwest Quarter of the Northeast quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$), Southeast quarter of the Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$), South half of Section Three (3), Lots One (1), and Southeast quarter of Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) Section Four (4), Township Thirty (30) North, Range One Hundred Six (106) West of the Sixth Principal Meridian, Wyoming, containing 652.53 acres.

2. The purchasers hereby agree to purchase said premises for the consideration of \$3,145.00 of which sum of \$1,145.00 has been paid, the receipt whereof is acknowledged, and the balance of \$2,000.00 payable within four years at five per cent interest as evidenced by a note of even date.

3. The seller agrees to furnish an abstract of title to said premises, and to deliver to purchasers a Warranty Deed conveying a good and marketable title to said premises free and clear of all encumbrances at the time of the payment in full of this contract, said deed to be attached to this agreement. Seller agrees to deliver possession of said premises at the execution of this contract.

4. In the event of failure to pay the balance of the purchase price within the time set, seller may reenter the premises and this contract shall become null and void and title to said property shall revert in seller.
